**CALL TO ORDER**

Gary Christmann, Chair, called the meeting to order.

**INTRODUCTIONS**

Gary Christmann introduced new members Lt. Colonel Lawrence O'Toole, St. Louis Metropolitan Police Department, and Sara Gamblin-Luig, St. Louis City Emergency Management Agency.

**APPROVAL OF MINUTES OF FEBRUARY 11, 2016 MEETING**

Motion was made by Debbie Beezley, seconded by Frank Arnoldy, to approve the minutes of the February 11, 2016 meeting. Motion passed unanimously.

**DISCUSSION ITEMS**

**Executive Director's Report**

Nick Gragnani, STARRS, explained that FY 2017 grant discussions are currently underway in Congress. The proposed budget is \$757 million, which is a reduction of \$560 million from the

FY 2016 budget of \$1.3 billion. He encouraged members to contact local elected and legislative officials to express opposition to the reduction.

Mr. Gragnani advised that handbooks containing Board reference information will be distributed at the April Board meeting.

### **Greater St. Louis Region Critical Incident Stress Management Team**

Gary Christmann, reported that the Greater St. Louis Region Critical Incident Stress Management (CISM) Team is a volunteer organization, guided by a Board of Directors, that was established in 1991 to provide emergency responders within the entire bi-state region with confidential free access to education and crisis intervention services to minimize the effects of occupational stress related to traumatic, crisis or critical events and exposure. He advised that the CISM Team is activated for events or incidents that produce stress reactions beyond normal coping responses; when an individual requests support; where there are command or staff concerns; or when consultation may be beneficial. He noted that the CISM is certified through the International Critical Incident Stress Foundation.

## **ACTION ITEMS**

### **Finance Committee Report**

#### **FY 2016 UASI Grant Funding Recommendations**

Don Feher, St. Clair County EMA, advised that the Executive Budget Committee met on March 15, 2016 to select and prioritize funding recommendations for the FY 2016 grant totaling \$2,962,000. Of that amount, \$2,658,955 remains for distribution following the deduction for grant management and administration costs for the Missouri Office of Homeland Security and East-West Gateway Council of Governments. He reported that 59 projects totaling \$7,217,804 were submitted by the subcommittees for consideration. A summary of those projects, along with those selected for funding, were included in the meeting materials.

Motion approving the recommendations was made by Joann Leykam, seconded by Dave Todd. Motion carried, all voting aye.

### **Regional Security Expenditures**

Nick Gragnani, STARRS, summarized staff's recommendation of the following expenditures, totaling \$487,427. The expenditures will be funded from the U.S. Department of Homeland Security's Urban Area Security Initiative ("UASI") grant program.

Pursuant to the STARRS Bylaws, Article V, Section 2, the Executive Committee met to provide nominations for the STARRS Finance Committee and Nominating Committee. The meeting began at 1:05 p.m. with all members present and a quorum established.

Nick Gragnani provided an overview of the existing members of the Finance Committee – Don Feher (Chair), Gary Christmann, Abe Cook, Greg Brown, Joann Leykam, Debbie Mays, Mark Thorp, Dave Todd, and Jim Wild. Nick also presented a proposal to add a member to the Finance Committee to represent the Fusion Center.

The Finance Committee discussed adding a Fusion Center representative to the Finance Committee and ultimately decided that a decision about this would be made at a later date. Gary Christmann made a recommendation that the Board President, STARRS Executive Director, Fusion Center representatives, and representatives from the Law Enforcement Sub-Committee should meet to discuss whether the Fusion Center should be considered a separate Sub-Committee or should be considered part of the Law Enforcement Sub-Committee. Gary agreed to contact Nick within the next week to get this meeting organized.

Gary noted that since Barb Whitaker was no longer a member of the STARRS Board or the Finance Committee, the Finance Committee was lacking a representative from the public health sector. The Finance Committee discussed adding another member to the Finance Committee to represent the public health sector.

Gary Christmann made a motion to add a member to the Finance Committee, with the member to be either John Anthony or Justen Hauser. Joann Leykam seconded the motion. The motion passed unanimously. *Note – Per the bylaws, only Board of Directors members can serve on the Finance Committee, so the public health sector representative must be one of the two Public Health Sub-Committee members that serve on the Board (i.e. Anthony or Hauser).*

Nick provided an overview of the existing members of the Nominating Committee – Sgt. Bill Roche (Chair), Don Feher, Joann Leykam, and Warren Robinson. Gary Christmann made a motion to reaffirm Don Feher, Joann Leykam, and Warren Robinson as members of the Nominating Committee. Don Feher seconded the motion. The motion passed unanimously. *Note – Per the bylaws, Sgt. Bill Roche, as the Secretary of the Board of Directors, is automatically a member/the chair of the Nominating Committee, so his membership does not need to be recommended or approved by the Executive Committee.*

Subject: Authorization to Enter into Contracts for Emergency Response Cache Inventory & Assessment

Date: April 8, 2016

In March, East-West Gateway Council of Governments released a Request for Proposals (RFP) to hire a consultant to conduct an inventory and assessment of the hospital medical surge supplies and equipment that are staged at hospital locations in more than 40 emergency response trailer caches throughout the St. Louis region. This project will help the Council, STARRS, and emergency response agencies in the region ascertain the current operational readiness of the caches. Deliverables include updated inventory records, an assessment of the operational readiness of the caches, and recommendations for improvements to inventory and operational procedures.

The funding for this project will be provided by STARRS from the funds that it receives from the Hospital Donations which are provided by over 50 hospitals in the region to support regional emergency planning and preparedness efforts. The STARRS ESF-8 Subcommittee has requested that a portion of these funds be used to support the cache inventory and assessment project because the caches are housed and maintained by the hospitals in the region. Although the Council is STARRS's fiscal agent, the current agreements between the Council and STARRS do not cover expenditures related to this project, so there is a need for the Council and STARRS to sign an updated agreement that addresses these types of expenditures from the Hospital Donations account.

Responses to the RFP were due on March 30, 2016. The Council received submittals from 4 firms, including in no particular order:

- Alitek Consulting
- Emergency Preparedness Consulting, LLC
- Hagerty Consulting
- SES, Inc. with Lion CSG, LLC

The selection committee was comprised of six people, including staff from SSM Healthcare, St. Louis University Hospital, STARRS and East-West Gateway staff.

The selection committee members reviewed, scored, and ranked the submittals. Hagerty Consulting received the highest rank from the committee and was selected as the firm to be recommended for contract award for the project.

**Staff Recommendation:** Staff recommends that the Board of Directors authorize the Executive Director to expend STARRS funds and to approve and issue the necessary payments (i.e. signed checks, approved electronic transfers, etc.) to East-West Gateway Council of Governments in an amount not to exceed a total of \$120,000. These payments will be made to East-West Gateway Council of Governments to reimburse it for consultant costs associated with the cache inventory and assessment.

Staff also recommends that the Board of Directors authorize the STARRS Executive Director to execute an updated agreement with East-West Gateway Council of Governments that will govern the relationship between STARRS and East-West Gateway Council of Governments, including, but not limited to: the cooperation between the two entities, the fiscal agency and related costs, other expenditures that East-West Gateway Council of Governments makes or costs incurred at STARRS's request.

Subject: Regional Security Expenditures

Date: April 8, 2016

Staff is requesting authorization to expend funds in support of regional security that will improve the region's disaster preparedness and response capabilities. Funding will come from the U.S. Department of Homeland Security's Urban Areas Security Initiative (UASI) and the U.S. Department of Health and Senior Services, Assistant Secretary of Preparedness and Response (ASPR) grant programs. Attachment A summarizes these purchases totaling **\$540,390**. Also attached is a summary description of all budgeted expenditures from the UASI grants (Attachment B).

- 1. Ballistic Protection Equipment** – We are requesting approval to purchase 12 Ballistic Vest Systems for the Illinois Emergency Medical Services (EMS) Task Force. The vests will protect the EMS personnel when responding to an active shooter situation involving mass casualties. Total costs will not exceed **\$38,186**
- 2. Bomb Detection Portable X-ray System** - Recent national and international events along with intelligence information has highlighted the need for law enforcement bomb squads to have the capability to respond quickly using equipment that is easily deployable. This capability can address multiple improvised explosive device (IED) threats in a single location involving a large scale event as well as those spread across the region. To address this need, several local bomb disposal units have developed explosive ordinance disposal tools that are smaller in scale and thus more portable. Therefore, we are requesting approval to purchase two portable x-ray systems for the St. Louis Regional Bomb and Arson Unit. With the merger of the St. Louis County Police Department and the St. Louis Metropolitan Police Department Bomb Squads this equipment would be a shared resource that will serve the region as a whole. Total costs will not exceed **\$85,441**.
- 3. Pen-Link Software** – In March staff received a request from the St. Louis Metropolitan Police Department to purchase Pen-Link intelligence gathering software and equipment systems. This software and systems provides for the collection, storage and analysis of telephonic and IP-based communications, and is utilized by police departments across the country. The Pen-Link equipment that the St. Louis Metropolitan Police Department is requesting is compatible with the software that serves as the telecommunications intelligence and analysis software used by the department. We are requesting to purchase the software and equipment for an amount not to exceed **\$17,963**.

- 4. Bus Stretcher Ambulance Equipment** – In January staff received approval to purchase two Bus Stretcher Ambulance Conversion Kits that will allow temporary transformation of any passenger bus into a patient transport vehicle. We are now requesting approval to purchase additional accessories including oxygen distribution systems, equipment accessory mounts, stretcher support legs, and customized lighting systems. These items will add important capabilities for patient care, nighttime use, and equipment security to the ambulance bus conversion units. These accessories will be split between the two storage sites in the City of St. Louis and St. Charles County. Total costs will not exceed **\$28,600**.
- 5. Controlled Air Purifying Respirators** – In 2014 we purchased 24 Maxair Systems Controlled Air Purifying Respirator (CAPR) units, storage carts/charging stations and supplies for regional hospitals with funding from the ASPR grant program. These systems are used by infectious disease response teams in hospitals during the treatment of patients with highly infectious diseases such as Anthrax, Ebola, smallpox, and others especially where exposure to bodily fluids or airborne contagions is an issue. We are requesting the purchase of 24 additional CAPR units to be staged at designated hospitals across the region. The CAPR Units will be disperse geographically among hospitals so they can be deployed regionally as needed. The total cost of this purchase will not exceed **\$51,350**.
- 6. Hazardous Materials Detection Meters** – The region’s hazardous materials response teams have identified a need for the ability to identify unknown chemicals in gas form. Chemicals that pose toxic inhalation hazards can be the most difficult to detect and to protect first responders from. Recent technological advances have allowed manufacturers to produce portable instruments that can detect and identify airborne chemicals even if there are several mixed together in a hazardous environment. The selected instrument has a library of over 5,000 chemicals and can identify up to 25 gases simultaneously. We are requesting approval to purchase five gas chemical analyzer units. They will be staged with the City of St. Louis, Jefferson County, Madison County, St. Charles County, and St. Louis County hazardous materials response teams. Total costs will not exceed **\$318,850**.

All of the purchases described in this memo are being made in accordance with the agency’s procurement policy.

**Staff Recommendation:** Staff recommends that the Board approve the expenditure of funds as follows:

- for the purchase of 12 Ballistic Vest Systems from First Spear, LLC in an amount not to exceed **\$38,186**;

- for the purchase of two (2) Portable X-Ray Systems from Atlantic Diving Supply, Inc. in an amount not to exceed **\$85,441**;
- for the purchase of Pen-Link Software and Systems from Pen-Link, Ltd. in an amount not to exceed **\$17,963**;
- for the purchase of Bus Stretcher Ambulance Conversion kit accessories from First Line Technology in an amount not to exceed **\$28,600**;
- for the purchase of 24 MaxAir Systems Controlled Air Purifying Respirator units and related supplies in an amount not to exceed **\$51,350**; and,
- for the purchase of five Portable Gas FTIR Chemical Analyzer Instruments from Gasmeter Technologies, Inc. in an amount not to exceed **\$318,850**;

for a total amount not to exceed **\$460,440** from the UASI grant program and **\$79,950** from the ASPR grant program.
